By signing the application for Regular membership, you agree to abide by the AFTE Bylaws and Code of Ethics.

Please keep in mind the following things:

- There is no application fee for a Regular membership application. AFTE Dues must be current for the application to be accepted.
- The application requires (3) recommendations and (3) Certificates of Applicant Qualification, one each from three Regular AFTE members and must have original signatures. The preferred format for recommendations is the **Applicant Recommendation Form.** Those providing recommendations may also submit a traditional recommendation letter, which should state the working relationship between you and the person recommending you, and why that person feels you should be accepted as Regular Member. Any letters submitted must be individual in nature and not the same/essentially the same letter or memo signed by three different people. One copy of the Recommendation Form and Certificate of Applicant Qualification is included in this packet; they can also be found as downloadable files on the AFTE website (<a href="www.afte.org">www.afte.org</a>).
- If you are unable to obtain letters of recommendation from three Regular (or Distinguished) AFTE members, the Advisory Committee may be able to assist you. Contact the Chair of the Advisory Committee for information.
