Having reviewed the parties' *Stipulated Findings of Fact and Conclusions of Law and Request for Orders to Vacate Defendant's Conviction, Judgment of Guilt and Sentence, to Relieve Him of All Resulting Penalties, to Dismiss the Indictment and to Release Defendant from Incarceration*, and good cause shown,

IT IS HEREBY ORDERED vacating the defendant's conviction, judgment of guilt and sentence.

IT IS FURTHER ORDERED in the interest of justice that all charges against the defendant be and hereby are dismissed without prejudice.

IT IS FURTHER ORDERED vacating all previously imposed court-ordered financial obligations as a result of the defendant's conviction.

IT IS FURTHER ORDERED restoring all civil rights of the defendant which were lost or suspended by the conviction, including the right to possess a gun or firearm.


1 IT IS FURTHER ORDERED directing the Clerk of the Court to seal all records  
2 related to the defendant's arrest, charges, conviction, and sentence in this matter, and to  
3 permit future access only by the defendant or his counsel.

4 IT IS FURTHER ORDERED directing the Arizona Department of Corrections  
5 Rehabilitation and Reentry (ADCRR) to immediately release the defendant from  
6 incarceration.
